# EXECUTIVE TECHNICAL GROUP ON TRADE INTEGRATION AND FACILITATION

Crowne Plaza, Santiago, Chile
August 23, 2016

#### 1. BACKGROUND

Some of the objectives of the COSIPLAN Strategic Action Plan (PAE) 2012-2022 are to promote the development of the region by identifying and executing infrastructure projects that should strengthen physical integration, following sustainable socioeconomic development criteria, and preserving the environment and the balance of ecosystems.

Bearing these objectives in mind, the application of an indicative territorial planning methodology led to the identification of some projects that are structuring in nature, which made it possible to set up an Integration Project Portfolio. Furthermore, by means of the implementation of methodologies as well as the development of sectoral processes and complementary actions, attempts have been made at facilitating the execution and operation of the undertakings and the attainment of the objectives pursued.

At the IV Ordinary Meeting of COSIPLAN Ministers (2013), Argentina and Chile were appointed as coordinators of the Executive Technical Group (GTE) on Border Integration and Facilitation. During the first meeting of this GTE, which was held in 2014, the countries agreed to move forward in the consideration of this matter. The GTE met again in 2015, where the countries agreed to include cross-border integration as a line of action of the COSIPLAN indicative territorial planning process.

At the VI Ordinary Meeting of COSIPLAN Ministers (2015), the Guidelines for the Design of a Work Plan on Cross-Border Territorial Integration Planning were approved.

The COSIPLAN Work Plan 2016 provides for the organization of a new meeting of the GTE to work on concrete proposals that help make headway in cross-border integration planning. To this effect, the distribution of working documents and consideration of the subject in advance to the GTE face-to-face meeting has been provided for.

### 2. ELEMENTS FOR A WORK PLAN ON CROSS-BORDER TERRITORIAL INTEGRATION PLANNING WITHIN COSIPLAN

Pursuant to the guidelines approved at the XXVIII Meeting of COSIPLAN Ministers in December 2015, the countries aim at leading the work on territorial planning and sectoral processes with a comprehensive vision focused on regional border integration and cross-border movement facilitation plans, by creating a new line of action in which both issues converge on an integrated scope of work that addresses the complementarities of cross-border territories.

To such end, the purpose is to develop the following instruments:

- A Conceptual Framework for Cross-Border Integration within COSIPLAN
- A Methodology for Cross-Border Integration Territorial Planning
- A Border Observatory
- A Regional Technical Assistance Fund
- Training Mechanisms

**Conceptual Framework:** In order to design the Conceptual Framework for Cross-Border Integration, agreement has been reached to perform the following tasks:

- Identify the dimensions of analysis of border integration that will be addressed within the competence of COSIPLAN
- Identify the bilateral border regions (BBRs) and the projects of each country in them
- Define the expanse of the territories involved
- Analyze the border crossings and their optimization

As a starting point for this work, at the XXIX Meeting of IIRSA Technical Forum, held on April 6, 2016, in Montevideo, it was agreed to provide the first elements, beginning with a survey of up-to-date information on the circumstances at the border crossings with regard to border control and the population living at the immediate area of influence.

#### 3. OBJECTIVES OF THE MEETING

- a) Present a proposal to survey information to learn about the following:
  - The border control and territorial management models in the area of the different border crossings;
  - ii) The type of population in the area of influence of each border crossing and their particular circumstances;
  - iii) Achievements, experiences, lessons learned, and challenges.
- b) Share suggestions for the development of the proposal.

- c) Exchange preliminary ideas on the following:
  - The dimensions of analysis of border integration that will be addressed within the competence of COSIPLAN;
  - ii) The criteria for identifying the bilateral border regions (BBRs);
  - iii) The criteria for defining the expanse of the territories involved; and
  - iv) A survey of each country's projects in such regions.

To this end, the meeting will be organized in round tables where there will be an exchange of ideas on the topics already mentioned and brief documents containing the conclusions will be drafted. As a result of the event, the goal is to gather the elements that will help build the conceptual framework, which is expected to be further elaborated later on, along with the development of the other activities included in the work plan.

#### 4. METHODOLOGY

Round tables will be organized as follows:

#### Round Table 1: Border Crossings: Efficiency Standards for the Operation of Border Crossings

- Infrastructure and services standards
- Technology and communications standards criteria for a swift mechanism for technological update
- Workplace and housing standards
- Streamlining of operational flows and of procedures
- Contingency plans

## Round Table 2: Planning Applied to Border Integration: Localities in the Immediate Area of the Border Crossing and their Condition

- Conditions for the development of border population (health education culture)
- Habitat and the environment
- Basic utilities infrastructure (drinking water energy communications)

#### Round Table 3: Elements for a Conceptual Framework Taking into Account:

- Definitions concerning the dimensions of analysis of border integration
  - Expanse of the territories
  - Identification of the territorial areas
  - Criteria for identifying associated Portfolio projects

#### Round Table 4: Elements for the Design of Border Integration Plans

- Methodological criteria for the design of cross-border territorial integration plans
- Tools for the design of cross-border territorial integration plans
- Criteria for the design of specific plans in bilateral border regions
