### **1. INTRODUCTION**

The Strategic Action Plan (PAE) 2012-2022 is the result of a process of discussion and consensus reached within COSIPLAN in 2011. It was approved by the Ministers at the Second Ordinary Meeting of COSIPLAN (Brasilia, November 2011), and ratified by the Presidents at the Sixth Meeting of the UNASUR Council Heads of State (Lima, November 2012).

The PAE is based on the UNASUR Constitutive Treaty and the COSIPLAN Statutes and Regulations, and includes a review of the progress of its objectives and actions five years after its approval.

At the meeting held on April 19, 2017, in Buenos Aires, Argentina, it was agreed that the results of the PAE review exercise including the contributions made by the delegations would be presented during the meeting on PAE review that would take place on July 12, in Montevideo, Uruguay.
