The Planning Process carried out in the period: 2003–2006 resulted in the IIRSA Project Portfolio, which arose from:

- 1. GTEs of 8 out of the 10 Hubs, 2003-2004 ("IIRSA Book")
- 2. GTE of the Amazon Hub, 2005 ("Addendum to the Project Portfolio")
- 3. Record of the VIII Meeting of the CDE, held in December, 2006, in Quito, Ecuador

 - To update the data on the projects of the IIRSA portfolio in 2003-2006;
 - To carry out the First Planning Stage of the Hub: Paraguay-Paraná Waterway (HPP); and
 - To revise the Groups of Projects in each of the EIDs in order to confirm or redefine the groups of projects through:
 - (a) The inclusion of new projects in the EID and/or new projects in the groups that already exist
 - (b) The exclusion or redefinition of groups and/or projects

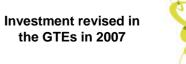

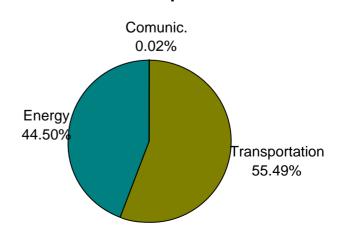

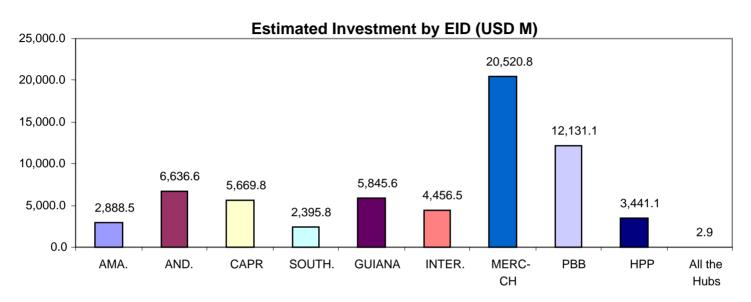
⇒ The planning works carried out in the GTEs, in 2007, resulted in 501 projects grouped in 47 groups for the IIRSA Project Portfolio.



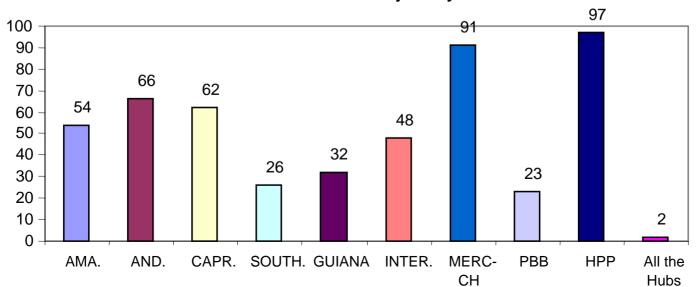
Work sessions of the GTEs, in 2007

Lines of Action, 2006-2010

Implementation

- ⇒ To ensure the implementation of the 31 projects in the AIC
- ⇒ To support the preparation of the projects in the IIRSA Portfolio
- ⇒ To obtain financing for projects of the IIRSA Portfolio

Planning - Stage II

- → To promote a quality leap regarding knowledge on the economic, social and environmental situation of the territory
- → To develop and apply new methodologies to support the IIRSA territorial planning process
- ⇒ To consolidate data on geographical bases South American GIS (GEOSUR)

Sectoral Processes

→ To identify actions (regulatory frameworks, rules, etc.) in order to free specific projects related to integration infrastructure, case by case (South American Gas Pipeline, etc)

Outreach

⇒ To let the South American community know the progress experienced by the IIRSA Initiative and the economic and social benefits derived from the projects on regional physical integration of IIRSA

⇒ Progress in the Implementation and Perspectives - 2010

- The Implementation of the projects of the AIC and the IIRSA Portfolio is one of the four cornerstones of the <u>IIRSA Strategic Objectives</u>, 2006-2010
- During 2007, the implementation process continues receiving technical and financial support thanks to the instruments implemented in the Initiative:
 - System of Information for Strategic Management (SIGE, in Spanish)
 - Financing mechanisms for studies related to the IIRSA Portfolio
 - Integration Fund BID
 - Infrastructure Fund CAF
 - Funds from FONPLATA
