Meeting of the Executive Technical Group on Trade Integration through Postal Services

Santiago, Chile

September 27, 2013

1. BACKGROUND

The "Exports through Postal Services for Micro-, Small-, and Medium-sized Enterprises (MSMEs)" project was presented to IIRSA member countries in 2005 by the Brazilian Communications Ministry. Its objective is to integrate micro-, small-, and medium-sized enterprises into the international market by implementing a simplified export system using the postal logistics platform. To date, this system is used in Brazil, Colombia, Ecuador, Peru, and Uruguay, and initial implementation work has begun in Argentina, Bolivia, Chile, and Venezuela.

In November 2011, within the COSIPLAN-IIRSA framework, the member countries decided to create a new, farther-reaching project under the name of "Trade Integration through Postal Services for MSMEs" with the purpose of covering both incoming and outgoing foreign trade in the countries of the region. This project, which incorporates exports through postal services as one of its components, is currently one of the actions identified as a priority in the COSIPLAN Strategic Action Plan (PAE) 2012-2022.

The Work Plan 2013 provides for a study on the best practices in simplification of customs postal operations for imports in South America, technical monitoring and preliminary diagnostic visits to the countries that have already implemented the exports through postal services project or expressed their interest in adopting the system, and a meeting of the Executive Technical Group on this matter.

2. OBJECTIVES

- Report the progress of the Work Plan 2013 in relation to the Trade Integration through Postal Services Project.
- Present the results of the Exports through Postal Services Project in the COSIPLAN-IIRSA member countries that have implemented it¹ and promote the exchange of experiences with the service.
- Present the "Study to survey the best practices for simplifying the customs import formalities for postal consignments" in South America. Analyze the proposal of a simplified model, including its regulatory, operational, economic and institutional feasibility.
- Agree on the Work Plan 2014 for the Trade Integration through Postal Services Project

- Identification of opportunities for cooperation among the countries to streamline the Exports through Postal Services facility.
- Consensus on the best practices for simplifying the postal customs operations for imports and on the implementation of the simplified model. Agreement over the countries interested in applying this model as a pilot experience.
- Work plan and calendar of activities for 2014 in relation to the Trade Integration through Postal Services Project.
