### Introduction

IIRSA starts its second phase (2011-2020) on the solid base of a Project Portfolio resulting from an intensive planning process, a vast set of studies and two planning methodologies.

Also, IIRSA starts this phase under a new institutional structure, within the framework of the Infrastructure and Planning Council of Ministers (COSIPLAN, for its acronym in Spanish) of the UNASUR.

The COSIPLAN has identified as one of its priority objectives the **boost to the execution** of projects for the national integration. The goal is to promote the "regional connectivity on the basis of the construction of networks for its physical integration, taking into consideration sustainable social and economics development criteria, protecting the environment and the balance of the ecosystems".

This new institutional framework is seen as an opportunity to boost the South American strategic infrastructure projects. It is necessary to identify a set of strategic infrastructure projects that deal with common priorities and decisions adopted by the UNASUR countries: this is essentially **the Priority Project Agenda (APP, for its acronym in Spanish)**.

## Background

Regarding a Priority Project Agenda, the Minutes of the IIRSA National Coordinators Meeting, in December 2010, established the following:

"(...) The basic concept of the new agenda would be to carry out the territorial connection among the countries and allow its efficient operation. The challenge is to have, at the end of the validity period of the new agenda, the infrastructure built, the proper regulations in force and its operation optimized (...)."

In that meeting, the CCT (Technical Coordination Committee) was asked to make a proposal that allows to structure this new Priority Project Agenda for the Initiative.

# Development, Approval and Starting of the APP Creation Process

- <u>Meeting of the CCT with Brazil's National Coordination, in Brasilia</u>. On March 30th, 2011, the mentioned meeting was held in order to present to the *pro témpore* presidency of the CISOPLAN a proposal developed by the CCT that allows to create, in 2011, a new Priority Project Agenda for the IIRSA. It was agreed to submit the proposal for the consideration of the National Coordinators of the IIRSA.
- Meeting of National Coordinators of the IIRSA, in Brasilia. This meeting was held on April 13th, 2011, and the proposal presented was widely discussed. Said proposal was enriched by the contributions of the participant delegations. It was agreed to submit the proposal for the consideration and approval of the next meeting of the Coordination Committee of the COSIPLAN.
- 3. <u>Meeting of the Coordination Committee of the COSIPLAN, in Rio de Janeiro</u>. On April 28th, 2011, the mentioned meeting was held and the methodology and procedure for the creation of a new Priority Project Agenda (APP) were approved.
- 4. The first step of the established methodology is the integral revision of the IIRSA Project Portfolio.

## Steps in the Development of the APP

- 1. Revision of the IIRSA Project Portfolio and preliminary identification of priority projects at a national level (May, 2011)
- 2. Revision of the IIRSA Project Portfolio and presentation of the priority projects (GTE –for its acronym in Spanish- in June, 2011)
- 3. Settlement of the priority projects at a national level
- 4. Development of a Priority Project Agenda (GTE, July, 2011)
- Approval of the Agenda by the NCs –National Coordinators- (XVIII Meeting of NCs)
- 6. Approval of the Agenda by the COSIPLAN

## Work Methodology

#### A. <u>Tasks to be previously completed by the countries</u>

1. Update of the dynamic fields in each project record in the date base: amount and current status.

Update deadline: <u>Tuesday, May 31st</u>

2. Preparation of one list per Hub in which the country is involved, including the projects intended to be added to and/or removed from the Portfolio (additions and withdrawals).

Deadline for submission to the CCT Secretariat: <u>Tuesday, May 31st</u>

3. Preparation of one list per Hub in which the country is involved, including the projects identified as candidates for their incorporation into the APP, as well as a brief description of the selection criteria met by each of them.

Deadline for submission to the CCT Secretariat: Monday, June 6th
