#### 1. BACKGROUND

One of the objectives of the COSIPLAN Strategic Action Plan (PAE) 2012-2022 is to "stimulate the application of methodologies and the development of sectoral processes and complementary actions in order to facilitate the design, execution and operation of physical integration projects" and, in relation to the development of sectoral processes, the PAE sets forth the action to "promote regulatory convergence to regulate the development and operation of the regional infrastructure."

Traditionally, the development of transport infrastructure and transport services has been approached in a separate, not articulated manner in the South American countries, which has not contributed to a provision and an operation efficient enough to attain sustainable economic and social development.

Over the last few years, increasing importance has been attached to an integrated analysis of transportation infrastructure and services from a multimodal perspective, which focuses on intermodal transfer points and uses logistics as the articulating component.

In this regard, the COSIPLAN seeks to establish logistics as a strategic focus to promote a systemic view of infrastructure, transport and logistics, which calls for the strengthening of this process both in each country and in the whole South American region by concentrating efforts to encourage public policies that address these aspects in a joint manner, and also by exploring convergence alternatives in the field of transport infrastructure and services in South America.

#### 2. OBJECTIVES

- A. Exchange experiences as well as any developments made and initiatives implemented in the UNASUR Member States in relation to freight transport and logistics.
- B. Identify joint action lines within COSIPLAN regarding logistics and the development of transportation services and logistics infrastructure for integration purposes.
- C. Define the next steps to be undertaken in connection with the training of the national teams in this subject as well as with information management, and assess whether it is relevant to develop methodologies to measure progress in the management of public policies concerned with freight transport and logistics.

#### 3. PARTICIPANTS

In addition to the National Coordinators, the Workshop calls for the participation of representatives from government agencies concerned with freight transport planning as well as with logistics services and infrastructure development to contribute their countries' experiences and promote a dialogue aimed at meeting the Workshop objectives and identifying the next steps and measures that can be adopted within COSIPLAN.
