### Background

- The identified problem supporting this proposal refers to the information available to roaming service users.
- IIRSA Regional Study verified this information is uncomplete, confusing and heterogeneous between operators and countries.
- To face this lack of knowledge, users switch off their terminal, which prevents an increase in the demand for roaming services .



# **Objective (1)**

- The aim of this proposal is to achieve transparency in the information provided to roaming service users, so that said information is complete, clear and homogeneous.
- Therefore, it is proposed to design a standard document format, containing the necessary information regarding the service offered by each operator.
- This information will be published under the "roaming" section in the web page of each operator and in the corporate web page of each regulator in the corresponding country.



# **Objective (2)**

- The standard format to be submitted by each operator shall contain <u>updated</u> information on:
  - Conditions for service activation
  - Services that will be available in each country (voice mail, caller ID, data, etc.)
  - Different roaming providers in each country
  - Final price for each roaming service (voice and data) offered by each of the providers
  - Existing commercial plans to reduce costs
  - Any other information operators may consider relevant



# Activities (1)

- 1) Countries formally accept the commitment for the adoption of this proposal.
- 2) Define information contents to be submitted to users and updating frequency.
- 3) Design the standard format by which the information will be published.
- 4) Define the mechanisms by which operators will submit information to regulators, in order to spread it.



## Activities (2)

- 5) Generate a periodical monitoring mechanism of the published information.
- 6)Establish how this initiative will be available to users.
- 7) Arrange regular revisions to see if contents are adequate regarding information needs of roaming service users.



### **Implementation (1)**

- Feasibility of Proposal
  - Proposal is considered viable since there is an agreement between operators and regulators on the need to improve information transparency for roaming service users.
  - No restrictions on costs and information availability are identified.
- Implementation Time Schedule
  - A time schedule of 6 months is proposed
  - Later on, this will be a permanent activity of updating information.



### **Implementation (2)**

#### • Estimated Cost

 All costs involved in the proposal to be included in the Project refer only to (1) design and implementation of information system; (2) computing system support; (3) costs related to public spreading of information system implemented.

#### • Proposals Participants

- Regulators and operators providing roaming services.

#### • Proposed Leadership

 In each country, the corresponding regulator. In South America, a sector organization/ institution to be defined, which would lead the project.
